## Assisted Dying Debate

Thank you to all our members who fed back to us and Deputies on their thoughts on the Assisted Dying Debate. It was certainly the most difficult debate to have. Due to members diverse views on the topic we did not take a stance on Assisted Dying itself but we did on the Requête, calling for greater protections to be in place (Capacity and discrimination legislation). ## 2nd Assisted Dying Debate – HSC

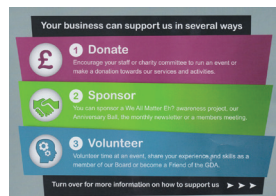
During the Assisted Dying debate proposition 5 were agreed, which instructs the Committee for Health & Social Care, in light of the ageing population and the substantial anticipated increase in health and care needs over the next ten to twenty years (abridged):

- To consider the measures necessary to improve quality of life and health outcomes for all islanders towards the end of their lives.
- to consolidate this work as far as possible with relevant ongoing workstreams under the Partnership of Purpose, the Supported Living and Ageing Well Strategy, and the Disability and Inclusion Strategy;
