

Should legislation be introduced to encourage access for the disabled within the historic town of St. Peter Port

This questionnaire will be open between the 7/10/16 to 6/11/16 Background:

In 2013 Guernsey's States of Deliberation agreed the Disability and Inclusion Strategy. This strategy is a step towards producing legislation in relation to discrimination against disabled islanders. A survey completed by the states of Guernsey in 2011 suggests that 21% of Guernsey's population (14,000 people) have a health condition that has, or will last for more than 12 months which can affect their daily life (Road et al., 2011). This proportion of Guernsey's population suggests that changes may need to be made to improve disability access. However, due to the lack of enforceable law in previous years many premises along St. Peter Port's pedestrianised streets may not provide adequate access for the disabled.

As a result, I am undertaking this questionnaire as part of my dissertation on a BSc Architectural Design & Technology program at Cardiff Metropolitan University to investigate perception



towards disability access within St. Peter Port's town from members of Guernsey's Disability Alliance.
