GDA January 2018 Update

2018 is an exciting year for the GDA. It is our 10th anniversary – a time for reflection, celebration and change, whilst evolving to ensure that we are ready to assist the community and businesses to understand and adapt to the situation ahead. Over the next few months, Rob Harnish (the manager at the Ron Short Centre) will be working alongside Karen on the Disability and Inclusion Strategy with the aim of freeing up more time to develop our future resources. GDA 10th Anniversary in 2018

It's 10 years since the GDA was formed by Dave Purdy, Rob Platts and Shelaine Green in response to the States of Guernsey request for one point of contact on disability matters.



Phase 1 - getting a strategy

2008 - 2013. Building momentum The first few years were spent building the more robust data, research and campaigning for the strategy.

Phase 2 - implementing the strategy 2014 -2018/19 - the last four years have been the most frustrating period as progress on the strategy and it's workstream we're painfully slow, especially in 2015 with the key resource not replaced and a lack of urgency & expertise for the key legislation project. The new assembly and committee (ESSC) May 2016 took some time to get up to speed but has now taken full ownership of the strategy, providing momentum, new expert resources for the legislation project and urgency for the ERO. These projects are 2 of the States Executive Committee and to our work-streams in order to ensure that we are fully prepared for the exciting times ahead.

It's not been a slow start to the year, we have already made good progress on a number of States projects including the ERO project, see Siriol Evans (here), an update on the Disability & Inclusion strategy & extra resources (here) and on 31st Jan a scrutiny meeting on the Disability & Inclusion Strategy will take place. Discrimination Legislation Update

The GDA founder and Equality Advisor, Rob Platts has provided an update on the Legislation project. Responsibility for developing legislation to protect people against discrimination by reason of disability passed by the Committee for Employment and Social Security in May 2016. A project team had been assembled, including representatives from the GDA and the Equalities Working Group. It was recommended that Guernsey's legislation be modelled on existing legislation from elsewhere and amended to suit Guernsey. ESSC identified six possible jurisdictions upon which to base Guernsey's legislation, and have recently advised that a good response to the tender process has been received and that a decision will be made shortly. Disability Officer Update

Good feedback received on Hidden Disabilities lanyard scheme launched on 1st Dec 17, at Guernsey and Alderney Airports. The free lanyards are



available from the Airport Information Desk, Health Information Guernsey, Wigwam, GDA, Guernsey Blind Association and other charities.

Two workshops have recently been held, the first on the possible scope, functions and remit of an Equality & Rights Organisation (ERO) which you can read about on this page below right. The second workshop is about promoting more positive and inclusive attitudes towards disability in the community.

The Committee for Employment & Social Security has identified the need for some expert policy and legislative advice to help the Committee to select legislation from another jurisdiction on which to model our own legislation. The next stage, with the help of a specialist, will be to develop proposals on how to tailor the model legislation to fit Guernsey.

Following the release of the polymer £5 note, the new £10 note, released in September 2017, is the most accessible yet. The Bank of England worked closely with RNIB to build accessibility into the design of the new £10 note.

In line with the Supported Living and Ageing Well Strategy, the States is developing a Carers Action Plan which will focus on the needs of people who care for or support family members

Fairness for all: Developing Guernsey's ERO

The States' Disability & Inclusion Strategy includes a resolution approving an equality and rights organisation (ERO). EROs are independent, statutory bodies designed to foster inclusion and prevent discrimination.

The resolution approves establishment of an ERO in principle, with implementation dependent on an approved business plan, funding and prioritisation. The Committee for Employment and Social Security commenced the workstream last year. The ERO Project Team includes GDA Executive Director Karen Blanchford representing the Equality Working Group (EWG), DIFERA/Liberate, Deputy Emilie Yerby and others.

The task at hand now is to engage stakeholders and develop the business case for an ERO suitable for Guernsey. A stakeholder input workshop was held in December 2017, and was preceded by an "ERO Primer" presentation by GDA Founder Rob Platts. Karen and Rob participated in the workshop, as did representatives from Citizens Advice Guernsey, Liberate and Safer, among others.
