Discrimination Law

An implementation group has been set up. This group will help with all the different tasks that need to be done before the Law is in place.

A training plan is being put together. It will be important for everyone to understand what responsibilities they will have with the new Law.

The Law Officers have started writing the first part of the new law.



Capacity Legislation

Health & Social Care is doing some work to get ready for the new Law.

A protective authorisation scheme will be set up.

This will protect people who cannot make their own decisions.



Dementia Framework

Le Platon have opened some new rooms which have especially designed for people with dementia.

The Alzheimer's Association have taken on an extra person who can sit with someone who has dementia. This means their family can go out for a short time.



Adult Safeguarding

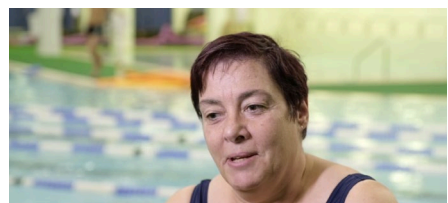
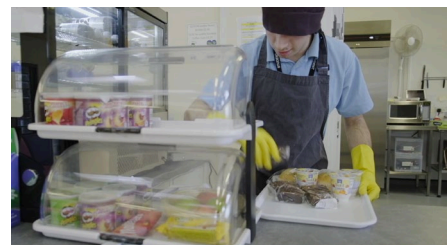
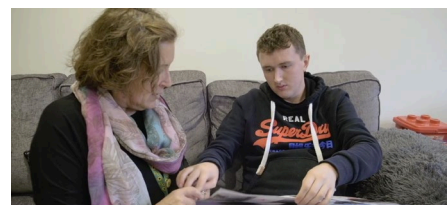
Three videos were made telling the stories of Alex, Liam and Sandra.

There are now beach wheelchairs for adults and children at Pembroke Bay. They will help wheelchair users go on the beach.

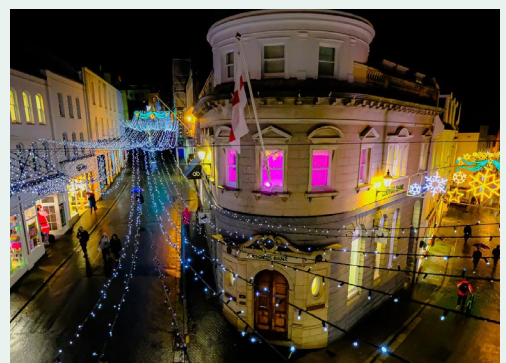


International Human Rights day.

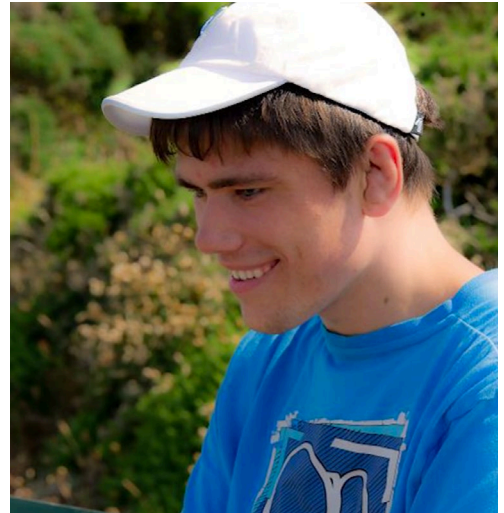
This day celebrates the rights that we all have.
